# **Hands & Voices Guide By Your Side Program:**

### **Part-Time Position for Parent Guides**

We currently have openings for parents of deaf/hard of hearing (DHH) children identified through newborn hearing screening in BC to join our team. At this time, applicants with the following perspectives or backgrounds will be prioritized: parents of DHH children with Indigenous ancestry, parents of DHH children with South Asian culture and language, parent of a DHH child with ANSD (Auditory Neuropathy Spectrum disorder) and parent of DHH child with additional medical needs.

The Hands & Voices Guide By Your Side program is a provincial service providing parent support by linking parents of babies newly identified deaf/hard of hearing in BC with trained "Parent Guides" & "Deaf/Hard of Hearing Guides". The program is operated through BC Early Hearing Program.

Guides are trained to support families without bias. We believe in the Hands & Voices motto, "What Works for your Child is what makes the Choice right."

# What is the role of the Parent Guide?

Parent Guides offer parents the opportunity to establish a supportive relationship with another parent, sharing stories about their experiences raising a child who is deaf/hard of hearing, as well as some of the practical advice a parent learns over the years (e.g. how did we keep those hearing aids on our baby's ears and out of his mouth?!).

A BC Early Hearing Program coordinator connects parents with Guides. Guides primarily contact parents by phone and email. There are also opportunities to meet parents at events (online and in-person).

**Request for Interest: Parent Guide Position** 

Hands & Voices Guide By Your Side Program (GBYS) BC Early Hearing Program (BCEHP)

#### **Duties & Responsibilities I**

The Parent Guide will contact families to provide non-biased information and support around resources available for children newly identified deaf/hard of hearing. Working on an as-needed basis with families, and under the guidance of the GBYS Coordinator, the responsibilities of the guides will include:

- The provision of timely parent-to-parent support at the time of identification. This will include making
  initial contact with families, collaborating with BCEHP / GBYS Parent & Deaf/Hard of Hearing Guide
  team members to determine information and resources required, and follow-up to ensure that
  families' needs are met.
- Maintenance of regular statistics and data logging of activities as necessary to the BCEHP.
- Attending monthly meetings for the purpose of collaboration and planning for the GBYS Program.
- Participation in initial training / educational activities as required (approx. 3 4 days) as well as ongoing 2-day GBYS team training provided twice per year (Friday/Saturday combination).
- Participation in the creation and review of materials used by the BC Early Hearing Program.

### Qualifications & Requirements

- First hand, current knowledge and understanding of the impact of reduced hearing levels on the family and the child (must be a parent of a child who is deaf or hard of hearing)
- The Indigenous Parent Guide self identifies as First Nations or Indigenous with ties to Indigenous ancestors.
- Knowledge of BC resources, communication, language and technology opportunities prevalent in the field of deafness.
- Contractors must be willing to maintain membership in BC Hands and Voices.
- Must have access to personal computer or laptop, internet and telephone or cell (voice and/or text).

#### Additional Details

Maximum 4-6 hours per week depending on need (not guaranteed); two full training days provided twice/year. Occasional travel required for trainings (held in Vancouver area), outreach and events.

This is a paid contract position. Hourly rate to be discussed. Interpreters and captioning provided for interview process, required trainings, monthly meetings and videoconferencing as required.
